Rules of order at Port of Kotor marina area

1. Upon arriving to the Port of Kotor you are obliged to register your arrival by providing personal documentation (passport and identity card) together with the relevant boat's documentation.
2. In the event of carrying out equipment from the boat, Port Officials must be acknowledged with the alternations in the Inventory list.
3. Any oil, oily bilges and residual spillage will be severely fined.
4. Open flame fires are strongly prohibited at the port. The boat must be provided with fire-fighting equipment and fire extinguishing instruments.
5. Within the confines of Port of Kotor aquatorium, swimming, fishing, motor boat or scooter driving is not permitted.
6. Before leaving the boat, all water and electrical connections must be switched off.
7. Connection to the distributing case is allowed only with the proper functioning cable and safety main switch provided that its amperage meets maximum permissible plug requirements.
8. Auxiliary boats, scooters, satellite antennas or other equipment fitting or keeping within the coast boundaries is not permitted.
9. You are obliged to tie your boat with your personal ropes in a usual way at the Port of Kotor marina area following the marina personnel instructions. Mooring ropes have to be in a good condition and the buoys must not disrupt other marina users. You are not allowed to place your personal buoys.

10. Within the confines of the marina area, dogs must be kept on a leash.
11. Maintenance and repair work onboard ship must not be carried out without the prior approval of the port authority.
12. Drying laundry within the marina area is not permitted.
13. No advertising or soliciting marks within the marina are permitted.
14. It is not allowed to cause nuisance and disrupt other guests. Noise shall not be made from 23:00 to 08:00h.
15. On entering the Port of Kotor marina area you are obliged to comply with the marina rules of order.
16. All remarks and suggestions can be made to the to port authority or can be written in the complaint book.
17. In the event of disregard of the marina rules of order it is possible to cancel the mooring services.
